Heart of Iowa School Tuition Organization, Inc. Income Eligibility Limits

The Heart of Iowa School Tuition Organization (STO), Inc. has complete discretion regarding grants awarded. The Heart of Iowa STO will send grants directly to the school where the student is enrolled, and the grant will be applied to the student's tuition account. If the student does not complete a full year of school, the awarded grant will be prorated based on the number of days enrolled, and the unused portion will be returned to the Heart of Iowa STO.

To be eligible for a grant, the **Taxable Income on your Iowa Tax Return** (Line #4 on the Iowa form; if using the federal form this line will be titled Total Income) cannot exceed the amount listed below for your household size. When using a State of Iowa return, this number will be the same number that is used to qualify for Education Savings Accounts. The Income Limits are based on 400% of the current Federal Poverty Guidelines.
